**General Conditions:-**

1. The engagement as a Project Assistant in the project is purely on contractual/temporary basis maximum for the period of duration of the project. In case the tenure of the project is more than one year the same will be extended on yearly basis till the duration of the project depending on the satisfactory performance of the incumbent. The engagement can be terminated by either side by giving one month's notice OR stipend in lieu thereof.
2. Total duration of project assistantship in CSIR Laboratories is maximum 5 years, if any, candidate has already served in any CSIR Lab, as P.A staff/JRF/SRF etc for five year, he is not eligible to apply.
3. It is not a CSIR-CSIO appointment and will not confer any right on the incumbent to any claim implicit or explicit on any position.
4. **Leave:** Project Assistant will be entitled for leave as per rule.
5. **Reservation:** As regards reservation, if all things are equal, SC/ST/OBC/PH candidates may be given preference over General candidates so as to ensure their representation.
6. Candidate should possess the required educational qualification / experience as on the date of interview. **Candidates whose result is awaited on date of interview are not eligible.**
7. **Mode of Selection:** The candidates will be interviewed by the respective Selection Committees and panel will be prepared. The Panel so prepared will be utilized for engagement as Project Assistants as and when requirement arises.
